SERVICES THROUGH SUNRISE'S RESIDENTIAL OR PSYCHIATRIC RESIDENTIAL TREATMENT FACILITIES ARE DESIGNED TO SERVE MALE OR FEMALE CHILDREN, AND ARE BASED ON A TREATMENT PLAN THAT ADDRESSES EACH CHILD'S INDIVIDUAL NEEDS. FOR EACH CHILD'S EDUCATIONAL NEEDS, SUNRISE COLLABORATES WITH LOCAL SCHOOL DISTRICTS.
