SUNRISE CHILDREN'S SERVICES PROVIDES CARE TO CHILDREN, AGES 8 TO 18, WHO HAVE DEVELOPED UNHEALTHY BEHAVIORS AND COPING METHODS AS A RESULT OF SEVERE ABUSE, NEGLECT OR SOME OTHER FAMILY CRISIS. SERVICES THROUGH SUNRISE'S RESIDENTIAL OR PSYCHIATRIC RESIDENTIAL TREATMENT FACILITIES ARE DESIGNED TO SERVE MALE OR FEMALE CHILDREN, AND ARE BASED ON A TREATMENT PLAN THAT ADDRESSES EACH CHILD'S INDIVIDUAL NEEDS. FOR EACH CHILD'S EDUCATIONAL NEEDS, SUNRISE COLLABORATES WITH LOCAL SCHOOL DISTRICTS. IN FY2019, SUNRISE PROVIDED 30,477 DAYS OF RESIDENTIAL TREATMENT SERVICES TO 224 CHILDREN AND 9,819 DAYS TO 99 CHILDREN IN PSYCHIATRIC RESIDENTIAL TREATMENT.

SUNRISE CHILDREN'S SERVICES PROVIDES THERAPEUTIC FOSTER CARE TO CHILDREN, FROM BIRTH TO AGE 21, WHO CAN BENEFIT FROM CARE WITHIN THE HOMES OF SPECIALLY TRAINED FOSTER FAMILIES. SUNRISE BENEFITS THESE CHILDREN AND FAMILIES BY 24/7 SUPPORT AND FOSTER-TO-ADOPT SERVICES AVAILABLE IN EVERY REGION OF KENTUCKY. SUNRISE USES A PROVEN, TREATMENT-BASED TRAINING MODEL EVALUATED ON OUTCOMES-BASED SUCCESS STANDARDS. IN FY2019, SUNRISE PROVIDED 94,356 FOSTER CARE DAYS TO 476 CHILDREN, AND 6,524 DAYS OF CARE TO 85 CHILDREN IN FOSTER-TO-ADOPT STATUS, WITH 65 CHILDREN HAVING FINALIZED ADOPTIONS IN THEIR FOREVER HOMES.

THESE INCLUDE DEPRESSION, ANXIETY, RELATIONSHIP ISSUES, TRAUMA, GRIEF/LOSS, AND MORE.
